2. Invigilation Duty & Evaluation work.
3. Helping students and colleagues in preparation and organization of different curricular / co-curricular activities in the Vidyalaya.
4. All other works assigned by the principal.

### N.B.:-

1. NO TA/DA shall be paid for appearing in walk-in-interview.
2. If the number of candidates is more for a particular post, then a **Screening Test** will be conducted for the same.
3. Appearing in interview does not confer the right to appointment on contractual basis. Part-time contractual engagement will be done in case any such vacancy arises or when teachers proceed on long leave. Teachers engaged on contractual basis, would have no claim or right for appointment on a regular basis nor will they be a part of the cadre of teachers of Kendriya Vidyalaya.
4. The part-time contractual teachers will be engaged till such time the regular teacher joins or the end of the academic session, whichever is earlier. Contrary to the above the services of a part time contractual teacher can be terminated any time if his/her performance is not up-to the mark.
5. Teachers engaged on contractual basis will not be entitled for vacation pay, and during Autumn / Winter Break, payment shall be calculated on pro rata basis.
6. Teachers engaged on contractual basis will not be entitled for pay, if they remain absent on working days. In case of absence from duty, payment will be calculated on pro rata basis.
7. The panel drawn on the basis of interview will be valid for one academic session (2023-24) only. Selected candidates to be engaged will be informed over phone or by e-mail only. So please provide your valid phone-number & e-mail Id. In case a candidate does not respond within 3 days the next candidate on the panel will be given chance and the candidature of the former will stand forfeited.
